Membership Agreement – Couples' Membership

BETWEEN BARRA TALASSO S.A., owner of the Nazaré Thalassotherapy Centre, situated at Avenida Manuel Remígio, Nazaré, hereinafter referred to as the 1st Grantor, and

holder of identity document number _____, hereinafter referred to as the 2nd Grantors, the following agreement is hereby entered into:

1. The Second Grantors undertake to join the Barra Talasso Club for a minimum period of one year, complying with the applicable rules of etiquette and the resulting obligations, in particular the timely and regular payment of membership fees.
2. The 1st Grantor undertakes to grant the 2nd Grantors access to the Thalasso Circuit (heated dynamic seawater pool, counter-current, waterfalls, foot bath, Turkish bath, contrast showers and ice fountain), in accordance with the option selected below:

3. The 1st Grantor further undertakes to grant the 2nd Grantors the following benefits:
 - a) Two medical consultations per year to assess physical condition;
 - b) Fifteen per cent (15%) discount on all services and products at Barra Talasso (not valid in conjunction with other offers). Members will always benefit from the most favourable discount currently available;
 - c) Fifteen per cent (15%) discount on accommodation at Miramar Hotels (not applicable on special dates);
 - d) Ten per cent (10%) off restaurant services at Miramar Hotels (not applicable to promotions or on special dates);
 - e) Discounts and preferential benefits on access to services provided by partner organisations, under specific agreements which will be publicised in due course.
4. For all intents and purposes, the 'Couple' membership category may be used by spouses or by two people who are first-degree relatives (parents, children or siblings).

5. Upon joining, the Second Grantors must pay a monthly advance payment (similar to a deposit).
6. Each month, the second signatories are obliged to pay the relevant monthly fee, even if they are unable to use the service during a particular period.
7. The Second Grantors may not transfer their sessions to third parties.
8. Sessions do not carry over from one month to the next; they can therefore only be used during the current month.
9. The monthly fee referred to in clause 6 shall nevertheless be payable where the second Grantors are unable to attend the Thalassotherapy Centre for health reasons. Where duly justified by a medical certificate, the first Grantor shall extend the validity period for the use of the sessions in question.
10. If one of the Second Grantors is temporarily unable to attend for health reasons, the other Grantor may make use of the remaining sessions included in the monthly fee.
11. The monthly fee referred to in point 6 shall only be waived if thalassotherapy is contraindicated.
12. During the loyalty period (12 months), the second Grantors may benefit from a one-month exemption from use (and the corresponding payment), at their discretion. To take advantage of this benefit, the second Grantor must notify the club of the intended month of exemption at least thirty (30) days in advance.
13. Once the twelve-month loyalty period has elapsed, should the Second Grantors decide to cancel their membership of the "Clube Barra Talasso", they shall have a period of 30 days following the termination of the contract to use any outstanding sessions. Unused Thalasso Circuit sessions cannot be converted into other products or services.
14. Any matters not covered in this document shall be resolved on a case-by-case basis between the two parties.
